ENTRY DEADLINE: FRIDAY, JUNE 21, 2019

FORMAT: 18-hole stroke play – net best ball of team. The tournament will not be flighted. There will be a gross and net champion.

ELIGIBILITY: All MISGA associates in good standing. Entrants must have an established valid USGA handicap computed and maintained at the associate's home club. Teammates of each team must be members of the same club.

HANDICAP ALLOWANCE:

1. 90% of each partner's July 1, 2019 handicap. 95% for ladies.
2. 10% reduction if partner's handicaps differ by more than 8 strokes.

TEE PLACEMENT: Estimated yardage for MISGA men is approximately 5800 yards. MISGA ladies tees are estimated at approximately 5600 yards. New tee descriptions/colors are currently under final review and development at Argyle, but Par will be 71 from both sets of tees.

ENTRY FEE: \$120 PER TEAM (\$60 PER PLAYER)

1. Includes coffee & donuts, cart & green fees, buffet luncheon and prize pool.
2. Please submit one check per club for all "Primary Entries". If space is available, "Alternate Entries" will pay at the time of registration.
3. Make the check payable to Argyle Country Club (memo note: *MISGA Two-Man Event*). Mailed checks must have a postmark on or before the June 21 deadline.
4. Provide full name and the most current handicap index of each entrant on the entry form. The player's handicap indexes will be updated to the July 1, 2019 numbers prior to start of the tournament.
5. Cancellation policy: Unless determined by the Tournament Committee, no refunds will be granted after Monday, July 1, 2019.

ADVANCING PLAYERS: The 10 low net teams and the 4 low gross teams will advance to the MISGA State Two-Man Team Championship at Holly Hills Country Club on Monday, August 5, 2019. If a qualified team selects NOT to play in the MISGA State Two-Man Team Championship, the first alternate team will replace that team.

TIE BREAKING PROCEDURE: The tie breaking procedure will be based on the MISGA mandated match-of cards for low net. The initial tie-breaker will be the best score attained for the last nine holes (10-18), then the last six holes (13-18), then the last three holes (16-18), and finally the 18th hole. If a tie still exists, the match will be a hole-by-hole match beginning with the #1 handicap hole, proceeding to the #2 handicap hole and so on until the tie is broken.
